Over 25 Years of Top Distribution: Lumberg Presents Award to JIT

Schalksmühle, 21.11.2018. In 1970 – German television viewers were able to receive the news "Tagesschau" from ARD and "Heute" from ZDF in color for the first time in March – the first Lumberg products were listed.. Together with Christian Forner, Head of Global Sales of the Lumberg Group, and Peter Maffei, Sales Manager Global Sales Distribution of Lumberg Connect, she presented the Lumberg-Icon, exclusively polished and engraved for JIT, at the world's leading trade fair for electrical engineering, which takes place every two years — right in front of the large colored Lumberg-Icon.
